

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2024 Department of Health and Human Services, Division of**  
**Child Welfare BIA Family Preservation Program Budget Amendment No. 1)**

**RESOLUTION NO. 23-424**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2024 Department of Health and Human Services, Division of Child Welfare**  
8 **BIA Family Preservation Program Budget in the amount of \$315,493.37 was**  
9 **approved by Resolution No. 23-158; and**

10 **WHEREAS, the Department of Health and Human Services, Division of Child Welfare**  
11 **prepared and submitted for review and approval its FY 2024 BIA Family**  
12 **Preservation Program Budget Amendment No. 1, which is incorporated by this**  
13 **reference and which will create new line items, adjust personnel and operational**  
14 **line items and decrease indirect costs that will change the budget amount of**  
15 **\$315,493.37 to \$314,810.37, and which shall be funded by the Nation's general**  
16 **fund pending reimbursement from the Bureau of Indian Affairs; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
18 **reviewed the FY 2024 Department of Health and Human Services, Division of**  
19 **Child Welfare BIA Family Preservation Program Budget Amendment No. 1 and**  
20 **recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2024 Department of Health and Human Services, Division of Child Welfare BIA**  
23 **Family Preservation Program Budget Amendment No.1 effective October 1, 2023,**  
24 **in the amount of \$314,810.37 that shall be funded by the Nation's general fund,**  
25 **pending reimbursement from the Bureau of Indian Affairs.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
27 **Nation chairperson or any designated official is authorized to administer and**  
28 **expend the FY 2024 Department of Health and Human Services, Division of Child**  
29 **Welfare BIA Family Preservation Program Budget as amended, provided**  
30 **however, that any amendments or modifications shall be submitted for prior**  
31 **approval by the Tohono O'odham Legislative Council.**
