

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Health and Human Services Komckud
Ki: Family Violence Prevention Services Grant Budget)**

RESOLUTION NO. 23-426

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2024 Division of Behavioral Health Komckud Ki:
9 Family Violence Prevention Services Grant Budget, which is incorporated by this
10 reference, in the amount of \$307,605.00 to be funded by the Nation's general fund
11 pending reimbursement by the grantor, the Department of Health and Human
12 Services Administration for Children and Families; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the FY 2024 Department of Health and Human Services Komckud Ki:
15 Family Violence Prevention Services Grant Budget and recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
17 FY 2024 Department of Health and Human Services Komckud Ki: Family Violence
18 Prevention Services Grant Budget effective October 1, 2023 through September
19 30, 2024 in the amount of \$307,605.00 which shall be funded by the Nation's
20 general fund pending reimbursement from the grantor, the Department of
21 Health and Human Services Administration for Children and Families.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2024 Department of Health and Human Services Komckud Ki
25 Family Violence Prevention Services Grant Budget, provided that any
26 amendments or modifications shall be submitted for prior approval by the
27 Tohono O'odham Legislative Council.

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
29 **day of NOVEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
30 **=0- AGAINST; =0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
