

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Addendum No. 2 to Tohono O'odham Long-Term Storage Credit Marketing Plan)

RESOLUTION NO. 23-428

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized to "manage, protect, and**
2 **regulate the use of the property, wildlife, land, air and natural resources**
3 **(including surface and ground waters) of the Tohono O'odham Nation." (TON**
4 **Const., Art. VI, § 1(i)(2)); and**

5 **WHEREAS, on August 27, 2019, the Nation implemented a Long-Term Storage Credit**
6 **Marketing Plan, which was completed on April 27, 2021; and**

7 **WHEREAS, on September 29, 2021, the Nation executed Addendum No. 1; and**

8 **WHEREAS, as of October 20, 2023, the Nation anticipates that it will generate additional Long-**
9 **Term Storage Credits; and**

10 **WHEREAS, Addendum No. 2 would amend the Marketing Plan to allow the Nation to continue**
11 **to market its Long-Term Storage Credits; and**

12 **WHEREAS, under Addendum No. 2 shall remain confidential and shall not be reported or**
13 **disclosed; and**

14 **WHEREAS, the Water Resources Committee has reviewed Addendum No. 2, which is**
15 **incorporated herein by this reference, to the Long-Term Storage Credit**
16 **Marketing Plan and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
18 **approves Addendum 2 to the Long-Term Storage Credit Marketing Plan, provided**
19 **that any sales contract under the Marketing Plan shall be submitted for approval**
20 **to the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
22 **day of NOVEMBER 2023 at a meeting at which a quorum was present with a vote of 2,980.6 FOR;**
23 **282.7 AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**
24 **by Article VI, § (1)(i)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
27 **(48 Stat.984).**
