The management of these funds shall be only 6 by a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS. by Chukut Kuk District Council Resolution No. 2023-27, the Chukut Kuk District 13 has authorized the FY 2024 Chukut Kuk District Mining Royalties Budget, which 14 is incorporated by this reference, in the amount of \$150,979.28; and 15 WHEREAS, the FY 2020 District Mining Allocation was authorized by Legislative Council 16 Resolution No. 20-240 and the FY 2023 District Mining Allocation was authorized 17 by Legislative Council Resolution No. 23-280; and 18 WHEREAS. the Budget and Finance Committee has reviewed the FY 2024 Chukut Kuk District 19 Mining Royalties Budget and recommends its approval. 20 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 21 FY 2024 Chukut Kuk District Mining Royalties Budget effective October 1, 2023 in 22 the amount of \$150,979.28, which shall be funded by the FY 2020 Chukut Kuk 23 District Mining Allocation in the amount of \$52,965.80 and FY 2023 Chukut Kuk 24 District Mining Allocation in the amount of \$98,013.48 as follows: 25 **Community** Amount 26 San Miguel Community \$26,928.74 27 **New Fields Community** \$26,928.74 28 Williams Ranch Community \$16,335.58 29 **Horseshoe Ranch Community** \$26,928.74 30 **Tecolote Community** \$26,928.74 31 Ak Komelik Community \$26,928.74 32 \$150,979.28
