

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024-FY 2025 Tohono O'odham Nation Health Care American
Rescue Plan Act Budgets)**

RESOLUTION NO. 23-433

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Health Care ("TONHC") Governing Body has**
8 **prepared and submitted for review and approval its FY 2024-FY 2025 TONHC**
9 **American Rescue Plan Act ("ARPA") Budgets, which are incorporated by this**
10 **reference, in the amount of \$18,730,473.00 to be funded by the U.S. Department of**
11 **Health and Human Services, as follows:**




