11		provide mutual aid and assistance in the field of law enforcement; and
12	WHEREAS,	the Domestic Affairs Committee has reviewed the Law Enforcement Mutual Aid
13		Agreement Between the Tohono O'odham Nation and the Town of Sahuarita and
14		recommends its approval.
15	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
16		Law Enforcement Mutual Aid Agreement Between the Tohono O'odham Nation
17		and the Town of Sabuarita.
