

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2024 Department of Education Child Care Services Program Child Care and Development Fund Discretionary 20PCAZCCDD Budget)**

**RESOLUTION NO. 23-448**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2) and (3); and**

7 **WHEREAS, the Department of Education has prepared and submitted for review and**  
8 **approval its FY 2024 Child Care and Development Fund Child Care & Development**  
9 **Fund Discretionary 20PCAZCCDD Budget, which is incorporated by this**  
10 **reference, in the amount of \$2,994,484.27 to be funded from the Nation's general**  
11 **fund pending reimbursement from the U.S. Department of Health and Human**  
12 **Services, Administration for Children and Families; and**

13 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
14 **reviewed the FY 2024 Department of Education Child Care Services Program Child**  
15 **Care and Development Fund Discretionary 20PCAZCCDD Budget and recommend**  
16 **its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2024 Department of Education Child Care Services Program Child Care and**  
19 **Development Fund Discretionary 20PCAZCCDD Budget, in the amount of**  
20 **\$2,994,484.27, which shall be funded from the Nation's General Fund pending**  
21 **reimbursement from the Grantor.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
23 **Nation chairperson or any designated official is authorized to administer and**  
24 **expend the FY 2024 Department of Education Child Care Services Program Child**  
25 **Care and Development Fund Discretionary 20PCAZCCDD Budget, provided that**  
26 **any amendments or modifications shall be submitted for prior approval by the**  
27 **Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
29 **day of DECEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
30 **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**
