**RESOLUTION NO. 23-449**

1   **WHEREAS,**     the Tohono O'odham Legislative Council is authorized "to manage any funds  
2                    within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3                    these funds for the benefit of the nation and its members" provided that "[a]ll  
4                    expenditures of these funds shall be pursuant to appropriations or budgets"  
5                    authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6                    Nation, Article VI, Section 1(d)(2) and (3); and

7   **WHEREAS,**     the Department of Education has prepared and submitted for review and  
8                    approval its FY 2024 Child Care and Development Fund Child Care & Development  
9                    Fund Mandatory 20PCAZCCDF Budget, which is incorporated by this reference, in  
10                   the amount of \$89,283.77, to be funded from the Nation's general fund pending  
11                   reimbursement from the U.S. Department of Health and Human Services,  
12                   Administration for Children and Families; and

13 **WHEREAS,**     the Human Resources Development and Budget and Finance Committees have  
14                    reviewed the FY 2024 Department of Education Child Care Services Program Child  
15                    Care and Development Fund Mandatory 20PCAZCCDF Budget and recommend its  
16                    approval; and

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
18                    FY 2024 Department of Education Child Care Services Program Child Care and  
19                    Development Fund Mandatory 20PCAZCCDF Budget, in the amount of \$89,283.77,  
20                    which shall be funded from the Nation's General Fund pending reimbursement  
21                    from the Grantor.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
23                    Nation chairperson or any designated official is authorized to administer and  
24                    expend the FY 2024 Department of Education Child Care Services Program Child  
25                    Care and Development Fund Mandatory 20PCAZCCDF Budget, provided that any  
26                    amendments or modifications shall be submitted for prior approval by the  
27                    Tohono O'odham Legislative Council.
