

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Legislative Branch Budget Amendment No. 1)**

RESOLUTION NO. 23-451

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2024 Legislative Branch Budget in the amount of \$5,610,093.46 was**
8 **approved by Resolution No. 23-193; and**

9 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY**
10 **2024 Legislative Branch Budget Amendment No. 1, which is incorporated by this**
11 **reference and will adjust operational and/or personnel line items; and**

12 **WHEREAS, the FY 2024 Legislative Branch Budget Amendment No. 1 will increase the FY 2024**
13 **Legislative Branch Budget by \$75,000.00 from \$5,610,093.46 to \$5,685,093.46; and**

14 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2024 Legislative Branch**
15 **Budget Amendment No. 1 and recommends its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2024 Legislative Branch Budget Amendment No. 1 effective October 1, 2023,**
18 **which includes a \$75,000.00 increase from \$5,610,093.46 to \$5,685,093.46 that**
19 **shall be funded by the Nation's surplus funds.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Legislative**
21 **Council chairperson or any designated official is authorized to administer and**
22 **expend the FY 2024 Legislative Branch Budget as amended, provided that any**
23 **amendments or modifications shall be submitted for prior approval by the**
24 **Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
26 **day of DECEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
