

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021-2024 HICKIWAN DISTRICT AMERICAN RESCUE PLAN ACT BUDGET)**

**RESOLUTION NO. 23-457**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only by**  
6 **a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

12 **WHEREAS, by HICKIWAN DISTRICT COUNCIL RESOLUTION HDC-23-017, the HICKIWAN DISTRICT HAS**  
13 **AUTHORIZED THE FY 2021-2024 HICKIWAN DISTRICT AMERICAN RESCUE PLAN ACT BUDGET,**  
14 **WHICH IS INCORPORATED BY THIS REFERENCE, IN THE AMOUNT OF \$2,777,081.00; AND**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021-2024 HICKIWAN**  
16 **DISTRICT AMERICAN RESCUE PLAN ACT BUDGET AND RECOMMENDS ITS APPROVAL.**

17 **NOW, THEREFORE, BE IT RESOLVED THAT THE TOHONO O'ODHAM LEGISLATIVE COUNCIL APPROVES THE**  
18 **FY 2021-2024 HICKIWAN DISTRICT AMERICAN RESCUE PLAN ACT BUDGET IN THE AMOUNT**  
19 **OF \$2,777,081.00 EFFECTIVE MARCH 11, 2021 THROUGH DECEMBER 31, 2024, WHICH SHALL**  
20 **BE FUNDED BY THE TOHONO O'ODHAM NATION RESCUE PLAN ACT FUNDS PURSUANT TO**  
21 **RESOLUTION NO. 21-292.**

22 **BE IT FINALLY RESOLVED BY THE TOHONO O'ODHAM LEGISLATIVE COUNCIL THAT THE FY 2021-2024**  
23 **HICKIWAN DISTRICT AMERICAN RESCUE PLAN ACT BUDGET SHALL BE MANAGED AND**  
24 **EXPENDED IN ACCORDANCE WITH ARTICLE IX, SECTION 7 OF THE CONSTITUTION OF THE**  
25 **TOHONO O'ODHAM NATION AND THE NATION'S LAWS, PROVIDED THAT ANY AMENDMENTS OR**  
26 **MODIFICATIONS SHALL BE AUTHORIZED UNDER DISTRICT COUNCIL RESOLUTION AND**  
27 **SUBMITTED FOR PRIOR APPROVAL BY THE TOHONO O'ODHAM LEGISLATIVE COUNCIL.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
29 **day of DECEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
30 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
31 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
32 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
34 **(48 Stat.984).**
