2		preserve and protect the natural and cultural environment of the Tohono				
3		O'odham Nation," and the Tohono O'odham Legislative Council is vested with the				
4		responsibility to "[p]reserve important historic, cultural and natural aspects of				
5		Tohono O'odham national heritage, and maintain an environment which				
6		supports diversity" (Constitution of the Tohono O'odham Nation, Article XVIII,				
7		Section 1 and Section 2(d)); and				
8	WHEREAS,	the Southwest Indian Agricultural Association ("SWIAA") was formed in 1987 with				
9		the stated purpose of promoting the future of agriculture on reservations, with				
10		tribes and individual Indian and non-Indian farmers, ranchers, and				
11		businessmen as founders of SWIAA; and				
12	WHEREAS,	membership in the SWIAA is open to any Indian organization recognized by its				
13		tribal government and/or federally recognized tribe with an interest in the				
14		management and development of Indian agriculture resources; and				
15	WHEREAS,	the Tohono O'odham Nation has a vested interest in the field of agriculture for its				
16		members; and				
17	WHEREAS,	by Resolution No. 21-353, the Legislative Council appointed Representative Mary				
18		Lopez as the Nation's representative and Representative Marlakay Henry as the				
19		Nation's alternate to the SWIAA; and				
20	WHEREAS,	Resolution No. 21-353 further provided that "any appointments made pursuant				
21		to [Resolution No. 21-353] shall immediately expire if the appointed				
22		representatives no longer serve on the Agricultural and Natural Resources				
23		Committee for any reason;" and				
24	WHEREAS,	the Nation currently is not represented on the SWIAA; and				
25	WHEREAS,	the Agricultural and Natural Resources Committee recommends the				
26		appointment of Representative Dallas Lewis as the Nation's representative and				
27		Representative Edward Manuel as alternate to SWIAA.				
28	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints					
29		Representative Dallas Lewis as the Nation's representative and Representative				
30		Edward Manuel as alternate to the Southwest Indian Agricultural Association.
