

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Enrollment or Adoption Applications for Membership in the Tohono
O'odham Nation for January 2024)**

RESOLUTION NO. 24-001

1 **WHEREAS,** Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the
2 Tohono O'odham Legislative Council with the power to "enact laws and
3 ordinances governing the enrollment and adoption of members and the
4 relinquishment and loss of membership"; and

5 **WHEREAS,** in accordance with the Tohono O'odham Nation Enrollment Ordinance,
6 Ordinance No. 05-81 as amended, the Enrollment Committee has reviewed and
7 recommended approval of the enrollment or adoption applications for the
8 individuals identified in the January 2024 Membership Applications List, which is
9 incorporated by this reference; and

10 **WHEREAS,** pursuant to Article VIII, Section 1 (C) (1) and (2) of the Enrollment Ordinance:

12 The final determination to approve or reject an application for
13 membership or adoption shall be recorded in a Council resolution. Each
14 determination shall set forth the following findings of fact:

15 (1) If an application for adoption is approved, the applicant's date of birth,
16 the degree of Papago-Tohono O'odham Indian Blood ascribed to the
17 applicant, and the Enrollment Committee's recommendation that the
18 application be approved or rejected;

19 (2) If an application for membership is approved, the applicant's date of
20 birth, the membership requirement which Council determined that the
21 applicant established, and the Enrollment Committee's
22 recommendation that the application be approved or rejected.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council has reviewed
24 the Enrollment Committee's recommendations and approves the applications
25 for enrollment or adoption that are identified in the January 2024 Membership
26 Applications List which includes the name, date of birth, enrollment number, and
27 membership requirement or, for adoption, the degree of Papago-Tohono
28 O'odham Indian blood for each applicant.

29 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH
30 day of JANUARY 2024 at a meeting at which a quorum was present with a vote of 3263.3 FOR;
31 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
32 Article VI, Section 1(a) or (b) and Section 2 and Article VI, Section 1(h) of the Constitution of the
33 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and
34 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
35 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
