

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Certification of A Tohono O'odham Nation Eligible Adult Member for
the Third Per Capita Distribution for January 2024)**

RESOLUTION NO. 24-006

1 **WHEREAS,** on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the
2 "O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes
3 per capita payments to the Nation's members provided that sufficient gaming
4 revenues are available; and

5 **WHEREAS,** the Ordinance for the Regulation of Gaming Activities Within the Tohono
6 O'odham Nation (the "Gaming Ordinance") was subsequently amended to
7 authorize per capita distribution payments in accordance with the Initiative
8 (Legislative Council Resolution No. 97-303); and

9 **WHEREAS,** the Legislative Council did adopt the Third Revenue Allocation Plan pursuant to
10 Legislative Council Resolution No. 06-307; and

11 **WHEREAS,** on July 28, 2006, the Secretary of the Department of Interior approved the Third
12 Revenue Allocation Plan; and

13 **WHEREAS,** the Tohono O'odham Nation Department of Membership Services submitted to
14 the Tohono O'odham Legislative Council the Master List for Eligible Adult Tohono
15 O'odham Members for the Third Per Capita Distribution ("Master List") for review
16 and approval; and

17 **WHEREAS,** Legislative Council approved the Master List with the initial number of 17,669
18 verified adult members (Resolution Number 06-624); and

19 **WHEREAS,** the disbursement of funds to each eligible adult member is contingent upon
20 verification of a member and certification by the Tohono O'odham Legislative
21 Council; and

22 **WHEREAS,** the Tohono O'odham Department of Membership Services has submitted a
23 certification list of one verified adult member who is listed on the previously
24 approved Master List and is eligible to receive the third per capita payment.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby:

- 26 1. Approves the verification and certification of the adult member listed on
27 the attached January 2024 Certification Listing of An Adult Member for the
28 Third Per Capita Distribution.
- 29 2. Approves the distribution of \$2,000, less any applicable taxes required by
30 federal law, to the adult member listed.



1 3. **Authorizes the Chairperson of the Nation or a designated official to**
2 **execute such other documents as may be necessary to implement this**
3 **resolution.**

4 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of**
5 **funds to additional eligible Tohono O'odham adult members is contingent upon**
6 **verification of membership by the Tohono O'odham Department of Membership**
7 **Services and certification by the Tohono O'odham Legislative Council.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
9 **day of JANUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -**
10 **0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
11 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
12 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
14 **18, 1934 (48 Stat.984).**


