

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Health and Human Services Division of Child Welfare
Title IV Subpart One and Two Budget Amendments No. 1)

RESOLUTION NO. 24-008

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2024 Department of Health and Human Services Division of Child Welfare
8 Title IV Subpart One and Two Budgets totaling the amount of \$356,784.00 were
9 approved by Resolution No. 23-184; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2024 Title IV Subpart One and Two Budget
12 Amendments No. 1, which are incorporated by this reference, and which will
13 adjust personnel and operational line items and indirect costs; and

14 **WHEREAS,** the FY 2024 Department of Health and Human Services Title IV Subpart One and
15 Two Budget Amendments No. 1 will decrease the original budgets from
16 \$356,784.00 to \$343,158.00, a total combined decrease of \$13,626.00; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2024 Department of Health and Human Services Division of Child
19 Welfare Title IV Subpart One and Two Budget Amendments No. 1 and recommend
20 their approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2024 Department of Health and Human Services Division of Child Welfare Title
23 IV Subpart One and Two Budget Amendments No. 1 effective October 1, 2023, as
24 follows:

- 25 1. Title IV Subpart One Budget will decrease by \$1,192.00, from \$143,057.00.
26 to \$141,865.00.
- 27 2. Title IV Subpart Two will decrease by \$12,434.00, from \$213,727.00 to
28 \$201,293.00,

29 for a combined total decrease of \$13,626.00 from \$356,784.00 to \$343,158.00 and
30 which shall be funded by the Nation's general fund pending reimbursement from
31 the grantor, the Department of Health and Human Services Administration for
32 Children and Families.

2 **Nation chairperson or any designated official is authorized to administer and**
3 **expend the FY 2024 Department of Health and Human Services Division of Child**
4 **Welfare Title IV Subpart One and Two Budgets as amended, provided that any**
5 **amendments or modifications shall be submitted for prior approval by the**
6 **Tohono O'odham Legislative Council.**


7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**

10 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
11 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
13 **18, 1934 (48 Stat.984).**






