RESOLUTION NO. 24-009

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Department of Health and Human Services ("DHHS") Division of
8 Senior Services Title III B-1 Transportation Budget in the amount of \$17,306.00,
9 FY 2024 DHHS Division of Senior Services Title III C-1 Congregate Budget in the
10 amount of \$45,476.00, and FY 2024 DHHS Division of Senior Services Title III C-2
11 Home Delivered Meals Budget in the amount of \$41,060.00 were approved by
12 Legislative Council Resolution No. 23-190; and

13 **WHEREAS,** the DHHS has prepared and submitted for review and approval its FY 2024 DHHS
14 Division of Senior Services Title III B-1 Transportation Budget Amendment No. 1,
15 FY 2024 DHHS Division of Senior Services Title III C-1 Congregate Budget
16 Amendment No. 1, and FY 2024 DHHS Division of Senior Services Title III C-2 Home
17 Delivered Meals Budget Amendment No. 1 (collectively, "FY 2024 DHHS Division of
18 Senior Services Title III Budgets Amendments No. 1"), which are incorporated by
19 this reference, and which will adjust personnel and/or operational line items;
20 and

21 **WHEREAS,** the DHHS has prepared and submitted for review and approval its FY 2024 DHHS
22 Division of Senior Services Title III Information and Referral Budget in the
23 amount of \$1,000.00 and FY 2024 DHHS Division of Senior Services Title III
24 Ombudsman Budget in the amount of \$5,000.00, which are incorporated by these
25 references to be funded by the Nation's general fund pending reimbursement by
26 the Grantor, Title III of the Older Americans Act through the Inter-Tribal Council
27 of Arizona; and

28 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
29 reviewed the FY 2024 DHHS Division of Senior Services Title III Budgets
30 Amendments No. 1, FY 2024 DHHS Division of Senior Services Title III Information

2 **Ombudsman Budget and recommend their approval.**

3 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
4 **FY 2024 Department of Health and Human Services Division of Senior Services**
5 **Title III Budgets, effective July 1, 2023 through June 30, 2024, which shall be**
6 **funded by the Nation's general fund pending reimbursement by the Grantor, Title**
7 **III of the Older Americans Act through the Inter-Tribal Council of Arizona, as**
8 **follows:**

- 9 **1. FY 2024 Department of Health and Human Services Division of Senior**
10 **Services Title III B-1 Transportation Budget Amendment No. 1, which**
11 **includes a \$694.00 increase from \$17,306.00 to \$18,000.00.**
- 12 **2. FY 2024 Department of Health and Human Services Division of Senior**
13 **Services Title III C-1 Congregate Budget Amendment No. 1, which includes**
14 **a \$3,876.00 decrease from \$45,476.00 to \$41,600.00.**
- 15 **3. FY 2024 Department of Health and Human Services Division of Senior**
16 **Services Title C-2 Home Delivered Meals Budget Amendment No. 1, which**
17 **includes a \$60.00 decrease from \$41,060.00 to \$41,000.00.**
- 18 **4. FY 2024 Department of Health and Human Services Division of Senior**
19 **Services Title III Information and Referral Budget in the amount of**
20 **\$1,000.00.**
- 21 **5. FY 2024 Department of Health and Human Services Division of Senior**
22 **Services Title III Ombudsman Budget in the amount of \$5,000.00.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2024 Department of Health and Human Services Division of Senior**
26 **Services Title III Budgets, provided that any amendments or modifications shall**
27 **be submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
29 **day of JANUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
