

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Department of Education One Stop Division PY22/FY23 Budgets)**

**RESOLUTION NO. 24-015**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Arizona Department of Economic Security Workforce Innovation and  
8 Opportunity Act ("WIOA") Title 1B, Intergovernmental Agreement ("IGA") (ADES  
9 Contract Number DI21-002302) was approved by Resolution No. 21-343; and

10 **WHEREAS,** Amendment No. 1 was approved by the Tohono O'odham Nation Legislative  
11 Council by Resolution No. 22-396; and

12 **WHEREAS,** Amendment No. 2 was approve by the Tohono O'odham Nation Legislative Council  
13 by Resolution No. 23-300; and

14 **WHEREAS,** the Arizona Department of Economic Security has granted the Tohono O'odham  
15 Nation Department of Education One Stop Division the amount of \$594,996.00 for  
16 the period beginning on April 1, 2022, through June 30, 2024; and

17 **WHEREAS,** the Department of Education has prepared and submitted for review and  
18 approval its FY 2024 One Stop Division PY22/FY23 Budgets, which are  
19 incorporated by this reference, in the total amount of \$594,996.00:

29 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have  
30 reviewed the FY 2024 Department of Education One Stop Division PY22/FY23  
31 Budgets and recommend their approval.


32 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
33 **FY 2024 Department of Education One Stop Division PY22/FY23 Budgets in the**

1 amount of \$594,996.00 effective April 1, 2023, which shall be funded by the  
2 Nation's general fund pending reimbursement from the Arizona Department of  
3 Economic Security.

4 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
5 Nation chairperson or any designated official is authorized to administer and  
6 expend the FY 2024 Department of Education One Stop Division  
7 PY22/FY23 Budgets, provided that any amendments or modifications shall be  
8 submitted for prior approval by the Tohono O'odham Legislative Council.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>  
10 day of JANUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;  
11 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
12 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
13 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
15 18, 1934 (48 Stat.984).






