

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Professional Service Agreement Between the Tohono O'odham
Nation and Liberty Elementary School District #25)**

RESOLUTION NO. 24-016

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Sections 1(f), (d)(2) and (3); and

7 **WHEREAS,** the Department of Education, Child Care Services Program wishes to enter into a
8 Professional Services Agreement with Liberty Elementary School District #25 to
9 provide child care services for the Nation's children who are eligible to receive
10 child care services; and


11 **WHEREAS,** the Human Resources Development Committee has reviewed the FY 2024
12 Professional Services Agreement and recommends its approval; and

13 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
14 FY 2024 Department of Education Child Care Services Program Professional
15 Services Agreement with Liberty Elementary School District #25, in substantially
16 the form attached.

17 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
18 Nation chairperson or any designated official is authorized to administer and
19 expend the FY 2024 Professional Services Agreement with Liberty Elementary
20 School District #25, provided that any amendments or modifications shall be
21 submitted for prior approval by the Tohono O'odham Legislative Council.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16th
23 day of JANUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;
24 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
25 Article VI, Sections 1(f), (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted
26 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
27 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
28 Act of June 18, 1934 (48 Stat.984).
