RESOLUTION NO. 24-037

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Constitution**
3 **of the Tohono O'odham Nation, Article II, Sections 1 and 2 and Article VI, Section**
4 **I(h)); and**

5 **WHEREAS, pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a written**
7 **recommendation to the Tohono O'odham Legislative Council to approve or reject**
8 **the application (14 Tohono O'odham Code Chapter 1 - Enrollment Ordinance);**
9 **and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
14 **membership and adoption applications misspelled or incorrectly listed the names**
15 **of members and/or incorrectly listed enrollment numbers; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 127-83, 01-416, 06-**
17 **261, 06-328, 06-449, 08-606, 09-167, 09-614, 10-103, and 10-401 be amended to**
18 **reflect the correct names and/or enrollment numbers of members identified in the**
19 **February 2024 Corrected Enrollment Resolution Summary, which is incorporated**
20 **by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
22 **Resolution Nos. 127-83, 01-416, 06-261, 06-328, 06-449, 08-606, 09-167, 09-**
23 **614, 10-103, and 10-401 are amended upon the effective date of those resolutions**
24 **to reflect the correct names and/or enrollment numbers of members identified in**
25 **the February 2024 Corrected Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
27 **day of FEBRUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3**
28 **FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the**
29 **Council by Article II, Sections 1 and 2 and Article VI, Section I(h) of the Constitution of the**
30 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**
31 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
32 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
