

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Paul Andrew to the Election Board for a Term Ending July 31, 2028)**

**RESOLUTION NO. 24-039**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**  
2 **appoint, or provide for the appointment of, and prescribe the duties and powers**  
3 **of committees, boards, officers and agents" (Constitution of the Tohono O'odham**  
4 **Nation, Article VI, Section 1(b)); and**

5 **WHEREAS, the Tohono O'odham Nation's Elections law, codified at 12 Tohono O'odham Code**  
6 **Chapter 1, authorizes the Tohono O'odham Legislative Council to appoint five**  
7 **bilingual members of the Tohono O'odham Nation to the Nation's Election Board**  
8 **(12 T.O.C. Chapter 1, Article III, Section 1301(A) and (B)); and**

9 **WHEREAS, the Nation's Elections law provides that Election Board members shall be**  
10 **"appointed . . . for a term of five years or until their successors are appointed" and**  
11 **further that "[a]ppointments to the [Election] Board shall be staggered so that the**  
12 **term of office of only one member will end in any single year" (12 T.O.C. Chapter**  
13 **1, Article III, Section 1301(B)); and**


14 **WHEREAS, Paul Andrew was appointed to the Election Board by Resolution No. 19-455 for a**  
15 **term ending July 31, 2023, and he continues to serve until his successor is**  
16 **appointed; and**

17 **WHEREAS, the Rules Committee recommends that Paul Andrew be appointed to the Election**  
18 **Board for a term ending July 31, 2028.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints**  
20 **Paul Andrew to the Election Board for a term beginning on the effective date of**  
21 **this resolution and ending July 31, 2028, provided that he shall continue to serve**  
22 **until his successor is appointed.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
24 **day of FEBRUARY 2024 at a meeting at which a quorum was present with a vote of 2,515.6**  
25 **FOR; 747.7 AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in**  
26 **the Council by Article VI, Section 1(b); Article X, Section 7 of the Constitution of the Tohono**  
27 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
28 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
29 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
