

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting a No Cost Extension for the Budget Term of the FY 2023 Department of
Health and Human Services "Get Fit. Don't Quit!" Apedag Program Budget and
Approving an Extension of the Budget Term)

RESOLUTION NO. 24-045

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation... and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2023 Department of Health and Human Services "Get Fit. Don't Quit!"**
8 **Apedag Program Budget in the amount of \$10,736.41 was approved by Resolution**
9 **No. 23-270; and**

10 **WHEREAS, the Health and Human Services and Budget and Finance Committees reviewed and**
11 **recommends accepting the no cost extension for the FY 2023 Department of Health**
12 **and Human Services "Get Fit. Don't Quit!" Apedag Program Budget and approve**
13 **the extension of the budget term beginning October 1, 2022 to September 30, 2024.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts**
15 **the no cost extension of the "Get Fit. Don't Quit! Apedag Program Budget and**
16 **approves the extension of the budget term beginning October 1, 2022 to September**
17 **30, 2024.**

18 **BE IT FINALLY RESOLVED that Tohono O' odham Legislative Council authorizes the Tohono**
19 **O'odham Nation chairperson or any designated official to administer and expend**
20 **the FY 2023 Department of Health and Human Services "Get Fit. Don't Quit!"**
21 **Apedag Program Budget for the period of October 1, 2022 through September 30,**
22 **2024, provided that any amendments or modifications shall be submitted for prior**
23 **approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
25 **day of FEBRUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3**
26 **FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the**
27 **Council by Article VI, Section 1(d)(2 and (3) of the Constitution of the Tohono O'odham Nation,**
28 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
30 **the Act of June 18, 1934 (48 Stat.984).**
