

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Health and Human Services Division of Senior Services Elders Activities Resources Budget)

RESOLUTION NO. 24-046

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the Department of Health and Human Services Division of Senior Services has
8 prepared and submitted for review and approval its FY 2024 Elders Activities
9 Resources Budget, which is incorporated by this reference, in the amount of
10 \$51,590.00 to be funded from funds donated by Desert Diamond Casino Golf
11 Classic; and

12 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
13 reviewed the FY 2024 Department of Health and Human Services Division of
14 Senior Services Elders Activities Resources Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
16 the FY 2024 Department of Health and Human Services Division of Senior Service
17 Elders Activities Resources Budget, effective October 1, 2023, in the amount of
18 \$51,590.00, which shall be funded from funds donated by Desert Diamond Casino
19 Golf Classic.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
21 O'odham Nation chairperson or any designated official is authorized to administer
22 and expend the FY 2024 Department of Health and Human Services Division of
23 Senior Services Elders Program Budget, provided that any amendments or
24 modifications shall be submitted for prior approval by the Tohono O'odham
25 Legislative.

26 **The foregoing Resolution** was passed by the Tohono O'odham Legislative Council on the 13TH
27 day of **FEBRUARY 2024** at a meeting at which a quorum was present with a vote of **3,263.3**
28 **FOR; -0-AGAINST; -0- NOT VOTING;** and **[02] ABSENT**, pursuant to the powers vested in the
29 Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,
30 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
31 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
32 the Act of June 18, 1934 (48 Stat.984).
