

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Health and Human Services Division of Senior
Services Title VI Amendment No. 1)

RESOLUTION NO. 24-048

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the FY 2023 Department of Health and Human Services Division of Senior**
8 **Services Title VI Budgets in the amount of \$265,010.00 were approved by**
9 **Resolution No. 22-148, later amended by Resolution No. 22-401 increasing the**
10 **amount to \$619,594.48, and again amended by Resolution No.23-230 to extend**
11 **the budget authority to FY 2024; and**

12 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
13 **review and approval its FY 2024 Title VI Part C Amendment No. 1, which are**
14 **incorporated by this reference, which will adjust personnel and operational line**
15 **items and decrease indirect costs with the total budget amounts remaining the**
16 **same; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2024 Department of Health and Human Services Division of**
19 **Senior Services Title VI Amendment No. 1 and recommend their approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
21 **the FY 2024 Department of Health and Human Services Division of Senior**
22 **Services Title VI Budget Amendment No.1, effective April 1, 2023, as follows:**

23 **1. Title VI Part C Caregivers Budget, no change to amount of \$162,989.85**

25 **which shall be funded by the Nation's general fund pending reimbursement from**
26 **the grantor, the Administration for Community Living, pursuant to Title VI of the**
27 **Older Americans Act of 1978.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
29 **O'odham Nation chairperson or any designated official is authorized to administer**
30 **and expend the FY 2024 Department of Health and Human Services Division of**
31 **Senior Services Title VI Budget as amended, provided that any amendments or**
32 **modifications shall be submitted for prior approval by the Tohono O'odham**
33 **Legislative Council.**




