

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2024 Department of Health and Human Services, Women, Infants and Children Program Inter-Tribal Council of Arizona Grant Budget Amendment No. 1)

RESOLUTION NO. 24-049

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2024 Department of Health and Human Services Women, Infants and
8 Children Program Inter Tribal Council of Arizona Grant Budget in the amount of
9 \$129,540.00 was approved by Resolution No. 23-187; and

10 **WHEREAS,** the Department of Health and Human Services prepared and submitted for review
11 and approval its FY 2024 Women, Infants and Children Inter Tribal Council of
12 Arizona Grant Budget Amendment No. 1, which is incorporated by this reference,
13 which increases the budget from \$129,540.00 to \$200,000.00, for a total increase
14 of \$70,460.00; and

15 **WHEREAS,** he Health and Human Services and Budget and Finance Committees have reviewed
16 the FY 2024 Department of Health and Human Services, Division of Community
17 Health Women, Infants and Children Inter Tribal Council of Arizona Grant
18 Budget Amendment No. 1 and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
20 the FY 2024 Department of Health and Human Services Women, Infants and
21 Children Inter Tribal Council of Arizona Grant Budget Amendment No.1 effective
22 October 1, 2023, which increases the budget from \$129,540.00 to \$200,000.00, a
23 total increase of \$70,460.00, that shall be funded by the Nation's general fund
24 pending reimbursement from the grantor, the Inter Tribal Council of Arizona.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
26 O'odham Nation chairperson or any designated official is authorized to administer
27 and expend the FY 2024 Department of Health and Human Services Women,
28 Infants and Children Inter Tribal Council of Arizona Grant Budget as amended,
29 provided however, that any amendments or modifications shall be submitted for
30 prior approval by the Tohono O'odham Legislative Council.


