

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Sif-Oidak District Gaming Revenue Budget Amendment No. 1 and
FY 2021-2024 Sif-Oidak District American Rescue Plan Act Budget Amendment No. 1
to reflect the Nation's Chart of Account Codes and Line Item Titles)

RESOLUTION NO. 24-058

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS,** the FY 2024 Sif-Oidak District Gaming Revenue Budget in the amount of
13 \$5,609,719.09 was authorized by Sif-Oidak District Council resolution and
14 approved by Legislative Council Resolution No. 23-440; and

15 **WHEREAS,** the FY 2021-2024 Sif-Oidak District American Rescue Plan Act Budget in the
16 amount of \$3,148,897.00 was authorized by Sif-Oidak District Council resolution
17 and approved by Legislative Council Resolution No. 23-324; and

18 **WHEREAS,** by Sif-Oidak District Council Resolution No. SODC 24-013, the Sif-Oidak District
19 has authorized and submitted for review and approval its FY 2024 Sif-Oidak
20 District Gaming Revenue Budget Amendment No. 1 and FY 2021-2024 Sif-Oidak
21 District American Rescue Plan Act Budget Amendment No. 1, which are
22 incorporated by these references; and

23 **WHEREAS,** the FY 2024 Sif-Oidak District Gaming Revenue and FY 2021-2024 Sif-Oidak
24 District American Rescue Plan Act Budgets are amended to reflect the Nation's
25 chart of account codes and line item titles but will not change the budget amount
26 totals; and

27 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2024 Sif-Oidak District
28 Gaming Revenue Budget Amendment No. 1 and FY 2021-2024 Sif-Oidak District
29 American Rescue Plan Act Budget Amendment No. 1 and recommends its
30 approval.

31 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
32 the FY 2024 Sif-Oidak District Gaming Revenue Budget Amendment No. 1 and the



FY 2021-2024 Sif-Oidak District American Rescue Plan Act Budget Amendment No. 1 effective October 1, 2023, which will not change the budget amounts.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2024 Sif-Oidak District Gaming Revenue Budget as amended and the FY 2021-2024 Sif-Oidak District American Rescue Plan Act Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH day of FEBRUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).




