

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
Service Grant American Rescue Plan Act Stabilization Budget Amendment No. 3)**

RESOLUTION NO. 24-063

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Hewel Ni'ok KOHN Corporation for Public Broadcasting ("CPB") Community
8 Service Grant ("CSG") American Rescue Plan Act ("ARPA") Stabilization Budget
9 in the amount of \$115,823.55 was approved by Resolution No. 21-458, amended
10 by Resolution No. 22-225, decreasing the original budget from \$115,823.55 to
11 \$107,963.31, and by Resolution No. 23-309, increasing the budget from
12 \$107,963.31 to \$257,960.19; and

13 **WHEREAS,** the Hewel Ni'ok KOHN CPB has prepared and submitted for review and approval
14 its FY 2024 CSG ARPA Stabilization Budget Amendment No. 3, which is
15 incorporated by this reference, and which will adjust operational and/or
16 personnel line items; and

17 **WHEREAS,** the FY 2024 Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget
18 Amendment No. 3 will decrease the FY 2024 Hewel Ni'ok CPB CSG ARPA
19 Stabilization Budget by \$415.83, from \$257,960.19 to \$257,544.36; and

20 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the
21 FY 2024 Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget Amendment
22 No. 3 and recommend its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approved
24 the FY 2024 Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget
25 Amendment No. 3 effective October 1, 2023, which decreases the budget amount
26 by \$415.83, from \$257,960.19 to \$257,544.36, and that shall be funded by the
27 Hewel Ni'ok KOHN CPB Community Service ARPA Grant.

28 **BE IT FURTHER RESOLVED** that Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget
29 funds are authorized until the grant funds are fully expended to provide continued
30 services.

31 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
32 O'odham Nation Chairperson or any designated official is authorized to administer
33 and expend the FY 2024 Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget

as amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.
