

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing and approving the Hewel Ni'ok Corporation for Public Broadcasting**  
**2020 CARES Budget Amendment No. 3)**

**RESOLUTION NO. 24-064**

1       **WHEREAS**, the Tohono O'odham Legislative Council is authorized "to manage any funds  
2       within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3       these funds for the benefit of the nation and its members" provided that "[a]ll  
4       expenditures of these funds shall be pursuant to appropriations or budgets"  
5       authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6       Nation, Article VI, Section 1(d)(2) and (3)); and

7       **WHEREAS**, the FY 2020 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community  
8       Services Grant CARES Stabilization Budget in the amount of \$125,393.44 was  
9       approved by Resolution No. 20-237, subsequently amended by Resolution No. 20-  
10      381 extending the budget authority to September 30, 2021, and by Resolution 21-  
11      457 extending the budget authority until funds are fully expended; and

12      **WHEREAS**, the Corporation for Public Broadcasting ("CPB"), in granting these funds to the  
13       Tohono O'odham Nation ("Nation") on behalf of Hewel Ni'ok, provided that the  
14       funds granted are not subject to CPB's statutory funding allocations, are  
15       considered unrestricted, and have no expenditure period; and

16      **WHEREAS**, the Nation has adopted a memorandum outlining the process for authorizing  
17       multi-year awards, the memorandum dated July 16, 2021 governs the budget  
18       authority for use of the CPB 2020 CARES grant until fully expended; and

19      **WHEREAS**, Hewel Ni'ok has prepared and submitted for review and approval its Hewel Ni'ok  
20       CPB 2020 CARES budget amendment no. 3, which is incorporated by this  
21       reference, and which will adjust Personnel, Operational and Capital line items;  
22       and

23      **WHEREAS**, Hewel Ni'ok CPB 2020 CARES budget amendment no. 3 will decrease the Hewel  
24       Ni'ok CPB 2020 CARES by \$1,311.04, from \$119,034.49 to \$117,723.45; and

25      **WHEREAS**, the Cultural Preservation and Budget and Finance Committees have reviewed the  
26       Hewel Ni'ok Corporation for Public Broadcasting 2020 CARES Budget  
27       Amendment No. 3 and recommend its approval.

28      **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council  
29       authorizes and approves the Hewel Ni'ok CPB 2020 CARES Budget Amendment  
30       No. 3, decreasing the Hewel Ni'ok CPB 2020 CARES by \$1,311.04, from  
31       \$119,034.49 to \$117,723.45, and which shall be funded by Hewel Ni'ok CPB 2020  
32       CARES grant.



5           **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
6           O'odham Nation chairperson or any designated official is authorized to continue  
7           administering and expending these funds until the grant funds are fully expended,  
8           and the Accounting Department is authorized to post the unexpended balances of  
9           the budget at fiscal year as a carry forward into the subsequent fiscal year and  
10          then thereafter into subsequent fiscal years until the grant funds are fully  
11          expended, provided that any amendments or modifications shall be submitted for  
12          prior approval by the Tohono O'odham Legislative Council.


13          The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>  
14          day of FEBRUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3  
15          FOR; 0 AGAINST; 0 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the  
16          Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,  
17          adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
18          Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
19          the Act of June 18, 1934 (48 Stat.984).






