

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Hewel Ni'ok KOHN Corporation for Public Broadcasting
Community Service Grant Restricted Budget Amendment No. 1)**

RESOLUTION NO. 24-065

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
8 Service Grant Restricted Budget in the amount of \$49,634.63 was approved by
9 Resolution No. 23-165; and

10 **WHEREAS,** the Hewel Ni'ok has prepared and submitted for review and approval its FY 2024
11 Budget Amendment No. 1, which is incorporated by this reference, and which will
12 adjust personnel line items and indirect costs estimates; and

13 **WHEREAS,** the FY 2024 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
14 Service Grant Restricted Budget Amendment No. 1 will increase the FY 2024
15 Hewel Ni'ok Corporation for Public Broadcasting Community Service Grant
16 Restricted Budget by \$14,746.71, from \$49,634.63 to \$64,381.34; and

17 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the
18 FY 2024 Hewel Ni'ok Corporation for Public Broadcasting Community Service
19 Grant Restricted Budget Amendment No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
21 the FY 2024 Hewel Ni'ok Corporation for Public Broadcasting Community Service
22 Grant Restricted Budget Amendment No. 1, effective October 1, 2023, which
23 increases the budget by \$14,746.71, from \$49,634.63 to \$64,381.34, that shall be
24 funded by FY2024 Hewel Ni'ok CPB CSG grant funds.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
26 O'odham Nation chairperson or any designated official is authorized to administer
27 and expend the FY 2024 Hewel Ni'ok KOHN Corporation for Public Broadcasting
28 Community Service Grant Restricted Budget as amended, provided that any
29 amendments or modifications shall be submitted for prior approval by the Tohono
30 O'odham Legislative Council.
