

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Hewel Ni'ok Corporation for Public Broadcasting Community
Service Grant Unrestricted Budget Amendment No. 1)

RESOLUTION NO. 24-066

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Hewel Ni'ok Corporation for Public Broadcasting Community Service
8 Grant Unrestricted Budget in the amount of \$229,983.73 was approved by
9 Resolution No. 23-164; and

10 **WHEREAS,** the Hewel Ni'ok has prepared and submitted for review and approval its FY 2024
11 Budget Amendment No. 1 which is incorporated by this reference, and which will
12 adjust personnel line items and the indirect cost estimates, as well as create and
13 fund operational line items; and

14 **WHEREAS,** the FY 2024 Hewel Ni'ok Corporation for Public Broadcasting Community Service
15 Grant Unrestricted Budget Amendment No. 1 will decrease the FY 2024 Hewel
16 Ni'ok Corporation for Public Broadcasting Community Service Grant Unrestricted
17 Budget by \$2,895.77, from \$229,983.73 to \$227,087.96; and

18 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the
19 FY 2024 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
20 Service Grant Unrestricted Budget Amendment No. 1 and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
22 the FY 2024 Hewel Ni'ok Corporation for Public Broadcasting Community Service
23 Grant Unrestricted Budget Amendment No. 1, effective October 1, 2023, which
24 decreases the FY 2024 Hewel Ni'ok Corporation for Public Broadcasting
25 Community Service Grant Unrestricted Budget by \$2,895.77, from \$229,983.73 to
26 \$227,087.96, that shall be funded by Hewel Ni'ok CPB CSG grant funds.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
28 O'odham Nation chairperson or any designated official is authorized to administer
29 and expend the FY 2024 Hewel Ni'ok Corporation for Public Broadcasting
30 Community Service Grant Unrestricted Budget as amended, provided that any
31 amendments or modifications shall be submitted for prior approval by the Tohono
32 O'odham Legislative Council.


