

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Hewel Ni'ok Administration Budget Amendment No. 1)**

RESOLUTION NO. 24-067

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Hewel Ni'ok Administration Budget in the amount of \$660,534.36
8 was approved by Resolution No. 23-192; and

9 **WHEREAS,** the Hewel Ni'ok Program has prepared and submitted for review and approval its
10 FY 2024 Hewel Ni'ok Administration Budget Amendment No. 1, which is
11 incorporated by this reference, and which will adjust personnel line items; and

12 **WHEREAS,** the FY 2024 Hewel Ni'ok Administration Budget Amendment No. 1 will decrease
13 the original budgeted amount by \$3,300.95, from \$660,534.36 to \$657,233.41;
14 and

15 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the
16 FY 2024 Hewel Ni'ok Administration Budget Amendment No. 1 and recommend
17 its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
19 the FY 2024 Hewel Ni'ok Administration Budget Amendment No. 1, effective
20 October 1, 2023, which will decrease the original budgeted amount by \$3,300.95,
21 from \$660,534.36 to \$657,233.41, and which will be funded by the Nation's
22 general fund.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
24 O'odham Nation chairperson or any designated official is authorized to administer
25 and expend the FY 2024 Hewel Ni'ok Administration Budget as amended,
26 provided that any further amendments or modifications shall be submitted for
27 prior approval by the Tohono O'odham Legislative Council.

28 **The foregoing Resolution** was passed by the Tohono O'odham Legislative Council on the 15TH
29 day of **FEBRUARY 2024** at a meeting at which a quorum was present with a vote of **3.263.3**
30 **FOR; -0- AGAINST; -0- NOT VOTING;** and **[02] ABSENT,** pursuant to the powers vested in the
31 Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,
32 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
33 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
34 the Act of June 18, 1934 (48 Stat.984).
