

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 05-002, 05-148, 06-059, 06-328, 07-236, 07-739,
and 10-103 to Correct Names and/or Enrollment Numbers of Enrolled Members

RESOLUTION NO. 24-072

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members (Constitution
3 of the Tohono O'odham Nation, Article II, Sections 1 and 2 and Article VI, Section
4 1(h)); and

5 **WHEREAS,** pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a written
7 recommendation to the Tohono O'odham Legislative Council to approve or reject
8 the application (14 Tohono O'odham Code Chapter 1 - Enrollment Ordinance);
9 and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council shall determine eligibility for membership or
12 adoption; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving
14 membership and adoption applications misspelled or incorrectly listed the names
15 of members and/or incorrectly listed enrollment numbers; and

16 **WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 05-002, 05-148, 06-
17 059, 06-328, 07-236, 07-739, and 10-103 be amended to reflect the correct names
18 and/or enrollment numbers of members identified in the March 2024 Corrected
19 Enrollment Resolution Summary, which is incorporated by this reference.

20 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that
21 Resolution Nos. 05-002, 05-148, 06-059, 06-328, 07-236, 07-739, and 10-103 are
22 amended upon the effective date of those resolutions to reflect the correct names
23 and/or enrollment numbers of members identified in the March 2024 Corrected
24 Enrollment Resolution Summary.

25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH
26 day of MARCH 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;
27 ~~0~~ AGAINST; ~~0~~ NOT VOTING; and ~~0~~ ABSENT, pursuant to the powers vested in the Council
28 by Article II, Sections 1 and 2; Article VI, Section 1(h) of the Constitution of the Tohono O'odham
29 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
30 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
31 16 of the Act of June 18, 1934 (48 Stat.984).






