

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2024 Department of Health and Human Services, Division of Child  
Welfare Services Children's Home Budget Amendment No. 1)**

**RESOLUTION NO. 24-084**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2024 Department of Health and Human Services, Division of Child Welfare  
8 Services Children's Home Budget in the amount of \$1,266,454.48 was approved  
9 by Resolution No. 23-192; and

10 **WHEREAS,** the Department of Health and Human Services, Division of Child Welfare Services  
11 prepared and submitted for review and approval its FY 2024 Children's Home  
12 Budget Amendment No. 1, which is incorporated by this reference, and which will  
13 adjust personnel and operational line items with the budget amount having no  
14 change; and

15 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
16 reviewed the FY 2024 Department of Health and Human Services, Division of  
17 Child Welfare Services Children's Home Budget Amendment No. 1 and recommend  
18 its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves  
20 the FY 2024 Department of Health and Human Services, Division of Child Welfare  
21 Services Children's Home Budget Amendment No.1 effective October 1, 2023, in  
22 the amount of \$1,266,454.48 that shall be funded by the Nation's General Fund.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
24 O'odham Nation chairperson or any designated official is authorized to administer  
25 and expend the FY 2024 Department of Health and Human Services, Division of  
26 Child Welfare Services Children's Home Budget as amended, provided however,  
27 that any amendments or modifications shall be submitted for prior approval by  
28 the Tohono O'odham Legislative Council.

29 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>  
30 day of MARCH 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;  
31 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council  
32 by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted  
33 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
34 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
35 the Act of June 18, 1934 (48 Stat.984).
