

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Health and Human Services Community
Health Budget Amendment No. 1)**

RESOLUTION NO. 24-085

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Department of Health and Human Services Community Health
8 Budget in the amount of \$2,490,633.75 was approved by Resolution No. 23-161;
9 and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2024 Community Health Budget Amendment No. 1,
12 which is incorporated by this reference, which increases the budget from
13 \$2,490,633.75 to \$3,036,771.31, a total increase of \$546,137.56; and

14 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
15 reviewed the FY 2024 Department of Health and Human Services Community
16 Health Budget Amendment No. 1 and recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
18 the FY 2024 Department of Health and Human Services Community Health
19 Budget Amendment No. 1, effective October 1, 2023, which increases the budget
20 from \$2,490,633.75 to \$3,036,771.31, a total increase of \$546,137.56 and shall
21 be funded by the Self-Governance Funding Agreement.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
23 O'odham Nation chairperson or any designated official is authorized to administer
24 and expend the FY 2024 Department of Health and Human Services Community
25 Health Budget, as amended, provided that any amendments or modifications shall
26 be submitted for prior approval by the Tohono O'odham Legislative Council.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH
28 day of MARCH 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;
29 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council
30 by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted
31 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
32 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
33 the Act of June 18, 1934 (48 Stat.984).
