

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Chukut Kuk District Mining Royalties Budget Amendment No. 2)**

**RESOLUTION NO. 24-088**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3           No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2024 Chukut Kuk District Mining Royalties Budget in the amount of  
13 \$150,979.28 was authorized by Chukut Kuk District Council Resolution No. 2023-  
14 27 and approved by Legislative Council Resolution No. 23-430, and subsequently  
15 amended by Legislative Council Resolution No. 23-459; and

16 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2024-04, the Chukut Kuk District  
17 Council has authorized and submitted for review and approval its FY 2024 Chukut  
18 Kuk District Mining Royalties Budget Amendment No. 2, which is incorporated  
19 by this reference and which will adjust operational and/or personnel line items;  
20 and

21 **WHEREAS,** the FY 2024 Chukut Kuk District Mining Royalties Budget Amendment No. 2 will  
22 not change the FY 2024 Chukut Kuk District Mining Royalties Budget; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2024 Chukut Kuk District  
24 Mining Royalties Budget Amendment No. 2 and recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves  
26 the FY 2024 Chukut Kuk District Mining Royalties Budget Amendment No. 2  
27 effective October 1, 2023 in the amount of \$26,928.74, which does not change the  
28 FY 2024 Chukut Kuk District Mining Royalties Budget.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2024  
30 Chukut Kuk District Mining Royalties Budget shall be managed and expended in  
31 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham  
32 Nation and the Nation's laws, provided that any amendments or modifications


