RESOLUTION NO. 24-098

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Legislative Council to approve or reject the**
8 **application (14 Tohono O'odham Code Chapter 1 - Enrollment Ordinance); and**

9 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
10 **O'odham Legislative Council shall determine eligibility for membership or**
11 **adoption; and**

12 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
13 **membership and adoption applications misspelled or incorrectly listed the**
14 **names and/or dates of birth of members; and**

15 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 06-449, 06-511,**
16 **06-578, 06-787, 07-007, 07-075, 07-112, 10-020, and 12-085 be amended to reflect**
17 **the correct name and/or date of birth of the members identified in the April 2024**
18 **Corrected Enrollment Resolution Summary, which is incorporated by this**
19 **reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
21 **Nos. 06-449, 06-511, 06-578, 06-787, 07-007, 07-075, 07-112, 10-020, and 12-085 are**
22 **amended upon the effective date of those resolutions to reflect the corrected**
23 **name and/or date of birth for members identified in the April 2024 Corrected**
24 **Enrollment Resolution Summary.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
26 **day of APRIL 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
29 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
31 **16 of the Act of June 18, 1934 (48 Stat.984).**
