6		director of the Tohono O'odham Gaming Office, subject to the approval of the
7		Legislative Council; and
8	WHEREAS,	1 T.O.C Chapter 4 and 16 T.O.C. Chapter 4, Section 402, establish background
9		investigation, criminal history review, and other requirements for the
10		appointment of the executive director of the Tohono O'odham Gaming Office, and
11		specifies that the appointment must be approved by majority vote of the
12		Legislative Council; and
13	WHEREAS,	pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono
14		O'odham Legislative Council, the chairperson's "appointee to the position of
15		treasurer or other officers or heads of governmental departments shall not be
16		added to any Legislative Council session agenda for approval unless the
17		appropriate legislative committee interviews the appointee after receiving a
18		resumé and written background investigation report" containing detailed
19		employment, education, credit, litigation, and other information necessary to
20		determine the appointee's qualifications and fitness; and
21	WHEREAS,	the Commerce Committee has received and reviewed the detailed written
22		background report required by the Legislative Rules, 16 T.O.C. Chapter 4, Section
23		402, and 1 T.O.C. Chapter 4, interviewed the appointee, and recommends that the
24		Legislative Council approve the appointment.
25	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
26		appointment of Mary Ann J. Ramirez as executive director of the Tohono O'odham
27		Gaming Office; provided that Mary Ann J. Ramirez shall serve until replaced at the
28		request of the Nation's chairperson.
