The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS. by Pisinemo District Council Resolution No. 24-P-14 the Pisinemo District has authorized and submitted for review and approval its FY 2024-FY 2025 Nestors 14 Community Mining Royalty Multi-Year Budget, which is incorporated by this reference, in the amount of \$29,948.56; and 16 WHEREAS. the FY 2023 District Mining Royalties allocation was authorized by Legislative 17 Council Resolution No. 23-280; and WHEREAS, the Budget and Finance Committee has reviewed the FY 2024-FY 2025 Pisinemo 19 District Nestors Community Mining Royalty Multi-Year Budget and recommends its approval. 21 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the FY 2024-FY 2025 Pisinemo District Nestors Community Mining Royalty Multi-Year 23 Budget effective October 1, 2023 through September 30, 2025 in the amount of 24 \$29,948.56, which shall be funded by FY 2023 Pisinemo District Mining Royalty 25 Allocation funds. 26 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2024-FY 2025 Pisinemo District Nestors Community Mining Royalty Multi-Year Budget shall be 28 managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that 30 any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.
