

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Planning and Economic Development Department Roads Program
North Komelik Community Loop PIR 153 & 1531 Budget Amendment No. 1)**

RESOLUTION NO. 24-139

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation ... and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section I (d) (2)); and

7 **WHEREAS,** the FY 2023 Planning and Economic Development Department Roads Program
8 North Komelik Community Loop PIR 153 & 1531 Budget in the amount of
9 \$520,194.00 was approved by Legislative Council Resolution No. 23-130; and

10 **WHEREAS,** the Planning and Economic Development Department Roads Program has
11 prepared and submitted for review and approval its FY 2024 Roads Program
12 North Komelik Community Loop PIR 153 & 1531 Budget Amendment No. 1, which
13 is incorporated by this reference, and which will adjust operational line items;
14 and

15 **WHEREAS,** the FY 2024 Planning and Economic Development Department Roads Program
16 North Komelik Community Loop PIR 153 & 1531 Budget Amendment No. 1 will
17 increase the FY 2024 Planning and Economic Development Department Roads
18 Program North Komelik Community Loop PIR 153 & 1531 by \$1,034,806.34 from
19 \$520,194.00 to \$1,555,000.34; and

20 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
21 have reviewed FY 2024 Planning and Economic Development Department Road
22 Program North Komelik Community Loop PIR 153 & 1531 Budget Amendment No.
23 1 and recommend its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY 2024 Planning and Economic Development Department Road Program North
26 Komelik Community Loop PIR 153 & 1531 Budget Amendment No. 1, effective
27 October 1, 2022 – September 30, 2025 which includes an \$1,034,806.34 increase
28 from \$520,194.00 to \$1,555,000.34, which shall be funded by the Nation's general
29 fund pending reimbursement by the grantor, the Bureau of Indian Affairs as
30 referenced in BIA WRO Master Contract A23AV00163 Modification No 1.



2 Nation chairperson or any designated official is authorized to administer and
3 expend FY 2023 - 2024 Planning and Economic Development Department Road
4 Program North Komelik Community Loop PIR 153 & 1531 Budget Amendment No.
5 1, provided that any amendments or modifications shall be submitted for prior
6 approval by the Tohono O'odham Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH
8 day of MAY 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-
9 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
10 Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
11 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
13 18, 1934 (48 Stat.984).






