

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Chukut Kuk District Budget Amendment No. 3)**

RESOLUTION NO. 24-140

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS,** the FY 2024 Chukut Kuk District Budget in the amount of \$2,792,116.12 was
13 **authorized by Chukut Kuk District Council Resolution No. 2023-25 and approved**
14 **by Legislative Council Resolution No. 23-364 and subsequently amended by**
15 **Legislative Council Resolution No. 23-459 and Legislative Council Resolution No.**
16 **24-087; and**

17 **WHEREAS** by Chukut Kuk District Council Resolution No. 2024-12, the Chukut Kuk District
18 **has authorized and submitted for review and approval its FY 2024 Chukut Kuk**
19 **District Budget Amendment No. 3, which is incorporated by this reference and**
20 **which will adjust operational and/or personnel line items; and**

21 **WHEREAS,** the FY 2024 Chukut Kuk District Budget Amendment No. 3 will increase the
22 **overall FY 2024 Chukut Kuk District Budget by \$20,448.99 from \$2,819,926.08 to**
23 **\$2,840,375.07; and**

24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2024 Chukut Kuk District
25 **Budget Amendment No. 3 and recommends its approval.**


26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
27 **FY 2024 Chukut Kuk District Budget Amendment No. 3 effective October 1, 2023,**
28 **which includes a \$20,448.99 increase from \$2,819,926.08 to \$2,840,375.07 that**
29 **shall be funded by FY 2023 carryover funds.**

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2024 Chukut
31 **Kuk District Budget as amended shall be managed and expended in accordance**
32 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**
33 **the Nation's laws, provided that any amendments or modifications shall be**

1 authorized under District Council resolution and submitted for prior approval by
2 the Tohono O'odham Legislative Council.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07th
4 day of MAY 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-
5 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
6 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
7 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
8 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
9 (48 Stat.984).




