

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2025 Department of Health and Human Services Division of Senior Services**  
**Title VI Part A, Title VI Part C, and Title VI Nutrition Services Incentive Program Budgets)**

**RESOLUTION NO. 24-145**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
8 **review and approval three budgets, hereby incorporated by this reference, to be**  
9 **funded by the Nation's general fund pending reimbursement by the grantor, the**  
10 **Administration for Community Living, pursuant to Title VI of the Older**  
11 **Americans Act of 1978, including the FY 2025 Division of Senior Services Title VI**  
12 **Part A Budget in the amount of \$196,530.00; Title VI Part C Budget in the amount**  
13 **of \$75,000.00; and Title VI Nutrition Services Incentive Program Budget in the**  
14 **amount of \$9,382.00; and**

15 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
16 **reviewed the FY 2025 Department of Health and Human Services Division of**  
17 **Senior Services Title VI Part A Budget, Title VI Part C Budget, and Title VI Nutrition**  
18 **Services Incentive Program Budget and recommend their approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **FY 2025 Department of Health and Human Services Division of Senior Services**  
21 **Title VI Part A Budget in the amount of \$196,530.00; Title VI Part C Budget in the**  
22 **amount of \$75,000.00; and Title VI NSIP Budget in the amount of \$9,382.00 for a**  
23 **period beginning April 1, 2024 to March 31, 2025, which shall be funded by the**  
24 **Nation's general fund pending reimbursement from the grantor, the**  
25 **Administration for Community Living, pursuant to Title VI of the Older**  
26 **Americans Act of 1978.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
28 **Nation chairperson or any designated official is authorized to administer and**  
29 **expend the FY 2025 Department of Health and Human Services Division of Senior**  
30 **Services Title VI Part A Budget, Title VI Part C Budget, and Title VI NSIP Budget,**  
31 **provided that any amendments or modifications shall be submitted for prior**  
32 **approval by the Tohono O'odham Legislative Council.**


