

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Hewel Ni'ok Dedicated Revenue Budget)**

RESOLUTION NO. 24-158

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** Hewel Ni'ok was authorized by Resolution No. 09-554 to set up a Dedicated
8 Revenue Account for the deposit of generated revenues including donations and
9 contributions received; and

10 **WHEREAS,** during fiscal years 2022 and 2023 Hewel Ni'ok received service revenues totaling
11 \$38,444.50 which remain unobligated, further, an unexpended balance of
12 \$8,195.54 remains from the FY 2023 budget for a total amount of \$ 46,639.84
13 available to be budgeted; and

14 **WHEREAS,** Hewel Ni'ok has prepared and submitted for review and approval its FY 2024
15 Hewel Ni'ok Dedicated Revenue Budget, which is incorporated by this reference,
16 in the amount of \$46,639.84 to be funded from the Dedicated Revenue Account;
17 and

18 **WHEREAS,** the Cultural Preservation and the Budget and Finance Committees have reviewed
19 the FY 2024 Hewel Ni'ok Dedicated Revenue Budget and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2024 Hewel Ni'ok Dedicated Revenue Budget effective October 1, 2023, in the
22 amount of \$46,639.84 which shall be funded from the Dedicated Revenue Account
23 of Hewel Ni'ok.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2024 Hewel Ni'ok Dedicated Revenue Budget, provided that any
27 amendments or modifications shall be submitted for prior approval by the
28 Tohono O'odham Legislative Council.

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
30 **day of JUNE 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
