

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Quarles & Brady LLP FY 2024 Attorney Contract)**

RESOLUTION NO. 24-165

1 **WHEREAS,** the Tohono O'odham Constitution vests the Legislative Council with the power to
2 "employ legal counsel for the protection and advancement of the rights of the
3 Tohono O'odham Nation" (Constitution of the Tohono O'odham Nation, Art. VI,
4 Sec. 2(a)); and

5 **WHEREAS** the Legislative Council approved the Quarles & Brady LLP FY 2024 Attorney
6 Contract by Resolution No. 23-297; and


7 **WHEREAS,** the scope of work for the Quarles & Brady LLP FY 2024 Attorney Contract is limited
8 to mining-related matters and the Office of Attorney General recommends
9 amending it to authorize advice and representation for other purposes; and

10 **WHEREAS,** the Domestic Affairs Committee has reviewed the Quarles & Brady LLP FY 2024
11 Attorney Contract amendment, which is incorporated by this reference, and
12 recommends its approval.

13 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
14 Quarles & Brady LLP FY 2024 Attorney Contract amendment and authorizes the
15 Nation's chairperson to execute it; provided that any further amendments shall
16 be submitted for prior approval by the Tohono O'odham Legislative Council.

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
18 **day of JUNE 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
20 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
21 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat.984).**




