

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Legislative Branch Budget Amendment No. 3)**

RESOLUTION NO. 24-174

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2024 Legislative Branch Budget in the amount of \$5,610,093.46 was**
8 **approved by Resolution No. 23-193 and subsequently amended by Resolution No.**
9 **23-451, which increased the budget amount from \$5,610,093.46 to \$5,685,093.46,**
10 **and Resolution No. 24-080, which did not change the budget amount of**
11 **\$5,685,093.46; and**

12 **WHEREAS, the Legislative Branch prepared and submitted for review and approval its FY**
13 **2024 Legislative Branch Budget Amendment No. 3, which is incorporated by this**
14 **reference and which will adjust personnel and operational line items; and**

15 **WHEREAS, the FY 2024 Legislative Branch Budget Amendment No. 3 will not change the total**
16 **budget amount of \$5,685,093.46; and**

17 **WHEREAS, the Budget and Finance Committee reviewed the FY 2024 Legislative Branch**
18 **Budget Amendment No. 3 and recommends its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2024 Legislative Branch Budget Amendment No. 3 effective October 1, 2023,**
21 **which will not change the total budget amount of \$5,685,093.46.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Legislative Council chairperson or any designated official is authorized to**
24 **administer and expend the FY 2024 Legislative Branch Budget as amended,**
25 **provided that any modifications shall be submitted to the Budget and Finance**
26 **Committee for approval on behalf of the Legislative Council and amendments**
27 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**
29 **day of JUNE 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
31 **Article V, Section 4; Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham**
32 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
33 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
34 **16 of the Act of June 18, 1934 (48 Stat.984).**
