

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Tohono O'odham Nation Health Care Budget Amendment)**

**RESOLUTION NO. 24-189**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2024 Tohono O'odham Nation Health Care Budgets in the amount of**  
8 **\$143,752,787.99 was approved by Resolution No. 23-191; and**

9 **WHEREAS, the FY 2024 Tohono O'odham Nation Health Care Budgets in the amount of**  
10 **\$144,874,503.15 were amended by Resolution No. 23-406; and**

11 **WHEREAS, the FY 2024 Tohono O'odham Nation Health Care Budgets in the amount of**  
12 **\$145,512,874.53 were amended by Resolution No. 23-432; and**

13 **WHEREAS, the FY 2024 Tohono O'odham Nation Health Care Budgets in the amount of**  
14 **\$145,617,726.20 were amended by Resolution No. 24-019; and**

15 **WHEREAS, the FY 2024 Tohono O'odham Nation Health Care Budgets in the amount of**  
16 **\$146,144,516.78 were amended by Resolution No. 24-061; and**

17 **WHEREAS, Tohono O'odham Nation Health Care ("TONHC") has prepared and submitted for**  
18 **review and approval budget amendment to the FY 2024 Tohono O'odham Nation**  
19 **Health Care Budget, as detailed below, which are incorporated by this reference,**  
20 **and which identify the budget being amended along with its total amount as**  
21 **follows:**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> day of JULY 2024 at a meeting at which a quorum was present with a vote of 3,263,3 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).




