

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024-FY 2025 Department of Education One Stop PL 102-477
Grant #A19AV00071 Carry Forward Multi-Year Budget)**

RESOLUTION NO. 24-191

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Education has prepared and submitted for review and**
8 **approval its FY 2024-FY 2025 One Stop PL 102-477 Grant #A19AV00071 Carry**
9 **Forward Multi-Year Budget, which is incorporated by this reference, in the**
10 **amount of \$1,160,462.19 to be funded from the U.S. Department of the Interior**
11 **Bureau of Indian Affairs; and**

12 **WHEREAS, the Human Resources Development Committee and Budget and Finance**
13 **Committee have reviewed the FY 2024-FY 2025 Department of Education One Stop**
14 **PL 102-477 Grant #A19AV00071 Carry Forward Multi-Year Budget and**
15 **recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2024-FY 2025 Department of Education One Stop PL 102-477 Grant**
18 **#A19AV00071 Carry Forward Multi-Year Budget effective October 1, 2023 through**
19 **December 31, 2024 in amount of \$1,160,462.19, which shall be funded by the U.S.**
20 **Department of the Interior Bureau of Indian Affairs.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2024-FY 2025 Department of Education One Stop PL 102-477 Grant**
24 **#A19AV00071 Carry Forward Multi-Year Budget, provided that any amendments**
25 **or modifications shall be submitted for prior approval by the Tohono O'odham**
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
28 **day of JULY 2024 at a meeting at which a quorum was present with a vote of 3,005.7 FOR; 257.6**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
