## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving FY 2025 Gu Achi District Budget)

**RESOLUTION NO. 24-192** 

1 WHEREAS. pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham 2 Nation. 3 No district council shall expend district funds except pursuant to budgets 4 authorized under resolutions of the district council and approved by the 5 Tohono O'odham Council. The management of these funds shall be only by a treasurer or other authorized officer of the district council who has 6 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 by Gu Achi District Council Resolution No. 0524-078, the Gu Achi District has WHEREAS. authorized the FY 2025 Gu Achi District Budget, which is incorporated by this 13 14 reference, in the amount of \$5,373,205.73; and the Budget and Finance Committee has reviewed the FY 2025 Gu Achi District 15 WHEREAS, 16 Budget and recommends its approval. NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 17 FY 2025 Gu Achi District Budget effective October 1, 2024 in the amount of 18 19 \$5,373,205.73, which shall be funded by the August 2024 District Gaming 20 Allocation. BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2025 Gu Achi 21 District Budget shall be managed and expended in accordance with Article IX, 22 Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, 23 provided that any amendments or modifications shall be authorized under 24 District Council resolution and submitted for prior approval by the Tohono 25 26 O'odham Legislative Council. The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH 27 day of JULY 2024 at a meeting at which a quorum was present with a vote of 1,770.35 FOR; 698.75 28 AGAINST; 794.2 [03] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council 29 by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the 30 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant 31

Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
