

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Gu Achi District Budget)**

**RESOLUTION NO. 24-192**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only by**  
6 **a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** by Gu Achi District Council Resolution No. 0524-078, the Gu Achi District has  
13 **authorized the FY 2025 Gu Achi District Budget, which is incorporated by this**  
14 **reference, in the amount of \$5,373,205.73; and**

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025 Gu Achi District  
16 **Budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2025 Gu Achi District Budget effective October 1, 2024 in the amount of**  
19 **\$5,373,205.73, which shall be funded by the August 2024 District Gaming**  
20 **Allocation.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2025 Gu Achi**  
22 **District Budget shall be managed and expended in accordance with Article IX,**  
23 **Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws,**  
24 **provided that any amendments or modifications shall be authorized under**  
25 **District Council resolution and submitted for prior approval by the Tohono**  
26 **O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
28 **day of JULY 2024 at a meeting at which a quorum was present with a vote of 1,770.35 FOR; 698.75**  
29 **AGAINST; 794.2 [03] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**  
30 **by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the**  
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat.984).**
