RESOLUTION NO. 24-195 1 WHEREAS. Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the 2 Tohono O'odham Legislative Council with the power to "enact laws and 3 ordinances governing the enrollment and adoption of members and the 4 relinquishment and loss of membership"; and 5 WHEREAS, in accordance with the Tohono O'odham Nation's Eurollment Ordinance, 6 Ordinance No. 05-81 as amended the Enrollment Committee has received a 7 written statement from 02 tribal members who have expressed their intent to 8 relinquish their membership with the Tohono O'odham Nation and the members 9 are identified in the July 2024 Relinquishment List, which is incorporated by this 10 reference: and 11 pursuant to Article IX Section 1 of the Enrollment Ordinance, WHEREAS. 12 13 A member of the Nation may relinquish his membership in the 14 Nation by submitting a written statement clearly expressing an 15 intent to relinquish his membership to the Council, a copy of 16 which must be served on the committee. The written statement 17 must be signed by the person wishing to relinquish his membership 18 or, if a minor or incompetent, by the parent(s), guardian or other 19 person legally authorized to act on his behalf. Relinquishment 20 does not require the approval of the Council, but is effective upon 21 receipt of the statement by the Council and cannot be subsequently 22 denied. Upon recognition by the Council that the individual has
