

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham
Nation for the month of July 2024)**

RESOLUTION NO. 24-195

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the**
2 **Tohono O'odham Legislative Council with the power to "enact laws and**
3 **ordinances governing the enrollment and adoption of members and the**
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance,**
6 **Ordinance No. 05-81 as amended the Enrollment Committee has received a**
7 **written statement from 02 tribal members who have expressed their intent to**
8 **relinquish their membership with the Tohono O'odham Nation and the members**
9 **are identified in the July 2024 Relinquishment List, which is incorporated by this**
10 **reference; and**

11 **WHEREAS, pursuant to Article IX Section 1 of the Enrollment Ordinance,**

13 **A member of the Nation may relinquish his membership in the**
14 **Nation by submitting a written statement clearly expressing an**
15 **intent to relinquish his membership to the Council, a copy of**
16 **which must be served on the committee. The written statement**
17 **must be signed by the person wishing to relinquish his membership**
18 **or, if a minor or incompetent, by the parent(s), guardian or other**
19 **person legally authorized to act on his behalf. Relinquishment**
20 **does not require the approval of the Council, but is effective upon**
21 **receipt of the statement by the Council and cannot be subsequently**
22 **denied. Upon recognition by the Council that the individual has**
23 **renounced his membership, his name shall be deleted from the**
24 **membership roll.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
27 **recognizes that the two individuals identified in the July 2024 Relinquishment**
28 **List have relinquished their membership in the Tohono O'odham Nation and**
29 **orders the removal of their names from the Nation's membership roll.**
