

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting July 30, 2024 Special Session to Approve Annual District Allocation Formula)

LEGISLATIVE ORDER NO. 24-200

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and
2 procedures to regulate all meetings of the Tohono O'odham Council, standing
3 committees, boards and special committees." (Constitution of the Tohono
4 O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Rules of the Tohono O'odham Legislative Council vest the Council
6 with the authority to "by majority vote, call for a special session" (Legislative
7 Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and


8 **WHEREAS,** Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative
9 Council provides that "All Legislative Council sessions shall be held at the Tohono
10 O'odham Legislative Council chambers located in Sells, Tohono O'odham Nation,
11 with the following exceptions . . . [a] majority of all the legislative representatives
12 may vote to hold a session in some location other than the chambers located at
13 Sells."; and

14 **WHEREAS,** the Budget and Finance Committee is requesting a special session on July 30, 2024
15 for approval of the annual district allocation formula.

16 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it sets a
17 special session on July 30, 2024, to be held at Tohono O'odham Community
18 College S-cuk Du'ag Maşcamakud for approval of the annual district allocation
19 formula.

20 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 09TH day of
21 JULY, 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST;
22 -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,
23 Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham
24 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian
25 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
26 Stat.984).


