6		designated housing entity in accordance with the Native American Housing		
7		Assistance and Self-Determination Act of 1996, 25 U.S.C. § 4101, et seq., P.L. 104-		
8		330, 110 Stat. 4016 ("NAHASDA") and is authorized to receive and administer the		
9		Indian Housing Block Grant ("IHBG") and to seek other funds to operate and		
10		expand affordable housing; and		
11	WHEREAS,	the TOKA wishes to continue providing new affordable housing to meet the needs		
12		of community members by submitting a 2024 Competitive IHBG application for		
13		\$6,000,000 and to leverage these funds with Indian Housing Rlock Grant funds for		
14		construction of 15 new low-income homeownership housing units to serve and		
15		improve the quality of life for tribal community members; and		
16	WHEREAS,	the Housing Committee has reviewed the 2024 Competitive IHBG application and		
17		recommends its approval.		
18	NOW, THERI	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:		
19		(1) the TOKA is authorized to submit a 2024 Competitive IHBG application for		
20		funding in the amount of \$6,000,000 and to leverage these funds with Indian		
21	1	Housing Block Grant funds to construct 15 new low-income homeownership		
22		housing units; and		
23		(2) the Nation certifies and confirms that it will assume environmental		
24		responsibilities under 24 CFR Part 58.		
25	BE IT FINALLY RESOLVED that the Tobono O'odham Legislative Council authorizes and direct			
26		the Nation's chairperson or any designated official to execute all documents		
27		necessary for the TOKA to submit the 2024 Competitive IHBG application and any		
28		documents that may require the Nation's chairperson's signature post award		
29	including the environmental review.
